

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.sempramedical.com and Sempra Medical Group and governs data collection and usage. Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us.
